IED CPD: Subsidy Control course 30th January 2024

We have introduced a new course on Subsidy Control, taking place on the 30th

January. Subsidy Control is a central aspect in the design of any funding intervention considered by the public sector. The 2021 legislation has been developed as a post Brexit response to the EU State Aid rules and is based around 7 principles. This important course will focus on when Subsidy Control applies, how the principles are applied and demonstrated to ensure compliance. We will also consider the work that Local Authorities need to

undertake to build approved projects as well as the support and enforcement regime. Over two hours attendees will understand the legislative position and will also gain ideas for how successful projects can be better brought forward.


